TERMS AND CONDITIONS: -

- Submission of Quotation: Sealed quotation should be superscribed as "Quotation for Renewal of Firewall/UTM subscription" addressing to "The Director, CENTRAL INSTITUTE OF ROAD TRANSPORT, BHOSARI, PUNE – 411 026." and handed over to the Admin Section.
- 2) Validity of offer: The offer should be kept valid for a minimum period of 60 days from the due date of opening of the quotation. In the case of successful tenderer, the approved prices shall remain valid till Purchase Order is fully executed.
- 3) Opening of Quotation: Quotation will be opened on the stipulated opening date/time in the presence of tenderers or their representatives whosoever may like to be present.
- 4) Rejection of quotation due to late submission: Late / delayed and incomplete quotation will be rejected. This Institute shall not be responsible for any delays in transit or otherwise due to postal and/or any other reason.
- 5) Specification: Complete specification of the goods/equipment's offered shall clearly be specified.
- 6) Taxes: The rates of GST if applicable, shall be indicated separately or else it will be presumed that no taxes are payable by CIRT.
- 7) Payment: Payment will be made within 30 workings days after successful activation/renewal of license/subscription.
- 8) The Director, CIRT reserves the right to reject any or all the quotation or partially accept or reject any or all the quotation without assigning any reasons.
- 9) The Director, CIRT also reserves the right to reject any or all offers in case the tenderers have put in their own terms & conditions. In case of any dispute, on any account related to the said quotation &/or any activity related thereto, the Director's decision will be final and binding on the tenderers.
- 10) In case of dispute between both the parties, same will be referred to the sole Arbitrator as per the Arbitration and Conciliation Act 1946 as amended by Arbitration and conciliation (Amendment) Act 2015. The Arbitrator will be appointed by CIRT at their discretion. The venue of the arbitration proceeding will be at Pune and the cost of the arbitration proceeding will be borne by each of the parties as to 50%. The language of the arbitration proceeding will be in English.
